TERMS AND CONDITIONS
Miss World PHILIPPINES Beauty Pageant 2017

1. The Miss World Philippines Beauty Pageant 2017 (hereinafter referred to as the “Contest”) is organized by ALV Events International, Inc. (hereinafter referred to as the “Organizer”). These Terms and Conditions shall apply to all stages of the Contest.
2. The Contestant must complete the Organizer’s Miss World Philippines Beauty Pageant 2017 Official Application Form and attend an interview which shall be held on the day of application or at any time and venue to be determined by the Organizer. ***A copy of the Contestant’s Passport must be attached to the Contestant Form. Original documents must be presented for verification purposes.*** Should a Contestant fail to comply with the aforementioned requirements, the Organizer has the right to reject the said application.
3. The Contestant affirms that she is and will continue to be a person of good moral character and personality, grace, poise, and is endowed with the beauty of face and figure.
4. The Contestant shall also have the ability to show compassion and understanding to others and is capable of speaking intelligently in public places.
5. The Contestant shall be a person with a clean and good background and is unlikely to bring disrepute to the Miss World Philippines Beauty Pageant 2017 or the Miss World Title.
6. Closing date for application for the pageant is **July 22, 2017**.
7. The Contestant assures that her performances shall not infringe the rights (including copyrights) of or defame or embarrass any person, firm, or company.
8. The Contest is open to all ***single born female citizens of the Philippines*** who shall ***not be less than 17 years of age or not more than 25 years in the relevant year and uses the prefix “Miss”*** before her name. ***Applicants aged 26 can still apply for the contest but will be deemed ineligible to win the Miss World Philippines title. She can, however, vie for the other titles of the pageant. The minimum height requirement is five feet five inches (5’5”) tall.***
9. The Contestant ***must be single and have never been married or have been through*** any marriage ceremony (valid or invalid, and/or civil, religious or tribal ceremonies) in any part of the world. The Contestant must also never have had a child and should the Contestant win, she must remain unmarried during her reign as a titleholder.
10. For Contestants who are below 21 years of age, they are required to have their parent’s/legal guardian’s consent and signatures on the Official Contestant Application Form.
11. The Contestant confirms that she has no record of charges or convictions in any court of law in the Philippines or any country.
12. An affirmation from the Contestant guaranteeing that she is not a fugitive nor she is wanted by any local or international law enforcement agency is needed.

13. By entering the Contest, the Contestant agrees that the Organizer shall have the exclusive right to take photographs, record or reproduce all or any part of her performances or other appearances in connection with the Contest. The Contestant also consent and agrees that the Organizer can record her performance(s) at all stages in the Contest (including the interview session, whether in the form of audio, audio-visual or photographs). By agreeing to the Terms and Condition, the Contestant acknowledges that the Organizer has the right to edit and to telecast any recordings made. The Contestant hereby assigns to the Organizer absolutely, all vested, contingent and future rights in her performances and the Organizer shall own the sole and exclusive rights to future performances. The Contestant further agrees to sign any documents necessary or complete any formalities to perfect this assignment/engagement.
14. The Contestant irrevocably grants to the Organizer all consents and waivers necessary for the Organizer to record and use her performances, in any manner and in any part of the world as the Organizer shall in its sole discretion deem fit without any condition. The Contestant acknowledges that the Organizer may publish and use any recording made by the Organizer, including without limitation of photographs, audio and/or visual recordings for the promotion and publicity of the Contest.
15. The number and selection of judges at each stage of the Contest shall be at the Organizer's sole discretion. The judges' decision at all stages of the Contest is final. Further inquiries, written or verbal appeals, shall not be entertained. The Contestant shall abide and accept any and all decisions made by the panel of judges and the Organizer concerning and without limitation to, decisions relating to the Contest, interviews with the contestant, and/or artist contracts (if any), the awards of prizes (if any), and the division of prizes (if any) in the event of a tie.
16. The Organizer shall provide a corresponding consequence to any Contestant who withdraws, for any reason whatsoever, from any stage of the Contest.
17. The Contestant agrees to be prepared to perform again for re-assignment in the event the Organizer deems it necessary to re-record any part of any round of the Contest,
18. The Contestant shall not, without the prior written consent of the Organizer, while participating in the Contest, enter or sign into any agreement with or participate in any other program produced by any person/company in the business of producing, transmitting or exhibiting programs for or on television/radio/print/web locally and internationally.
19. The Contestant shall make full and honest disclosure of information as requested in the Official Contestant Application Form. **The application shall be accompanied by recent three (3) copies or 5R colored photographs: one (1) headshot photo, one (1) full body swimsuit photo, and one (1) full body in a dress photo.** All photographs submitted shall be the property of the Organizer who may, without reference to any contestant, use the photographs for any reasonable purpose or publicity.
20. All information submitted in the Official Contestant Application Form shall be deemed to be current. In the event of any change of such details, the Contestant shall notify the Organizer immediately.
21. The Organizer shall be under no liability whatsoever to the Contestant or her personal representatives, in respect to any loss, damage or injury to life or property sustained by the Contestant at any stage of the Contest, unless such loss, damage or injury is caused by the Organizer's gross negligence.
22. Contestants who fail to attend sponsors' visits, training sessions, rehearsals, fashion shows, photo-shoots, recording sessions, coronation night or other special events related to the Contestant shall be given necessary sanctions that are not limited to, deduction of points for entry into the semi-finals. Furthermore,

the contract could be disqualified if the reasons for such absence are found to be unacceptable by the Organizer. The Organizer reserves the right to provide further consequence to such failure.

23. The Contestant shall at all times strictly comply with the Organizer's specifications/requirement (whether written or oral) as to the Contestant's appearance, behavior, conduct, skills, attire and/or accessories. Failure to meet such specifications/requirements shall result in disqualification from the Contest.
24. The Organizer reserves the right to disqualify any Contestant from the Contest on the grounds of desirable conduct and/or appearance.
25. Without the prior written consent of the Organizer, the Contestant shall not speak to the press or other media nor give any interviews or comments in relation to the Contest, the Contestant herself or other Contestants nor disclose any information whatsoever relating to the Miss World Philippines Beauty Pageant 2017 activities and the Organizer.
26. The Organizer reserves the right to add to, alter or substitute any item on the list of prizes offered before the Finals of the Contest. All the prizes that are won by the Contestant during the Contest shall not be transferable or exchangeable for cash.
27. Non-compliance with or breach of one or any of these Terms and Conditions shall immediately result to disqualification of the Contestant from further participation at any stage of the Contest, including the international contest. Any cash and prizes won by the said Contestant shall be forfeited.
28. The Contestant warrants that she is free to participate, enter and perform in the Contest, including the international Contest and is under no limitation, restriction or disability (contractual or otherwise) to do so.
29. Without the consent of the Organizer, no contestant shall at any time during the Contest commercially exploit or aid the commercial exploitation of her participation in the Contest in any way whatsoever.
30. In the event that the Contest is annulled, cancelled or postponed by circumstances beyond the reasonable control of the Organizer, the Contestant shall have no claims whatsoever against the Organizer.
31. The Organizer reserves the right to any amendment or variation of any of these Terms and Conditions without prior notice to any Contestant.
32. The chosen title holders including the 1st and 2nd runners up will be contracted to ALV Talent Circuit, Inc. during their reign from the date and night of the Coronation Ball to 15 months or until the next contest is held in the year 2018. A separate contract of agreement will be issued and signed upon winning the title.
33. By participating in the Contest, all Contestants agree to be bound by these Terms and Conditions.
34. These Terms and Conditions shall be governed by and construed in accordance with the laws of the Philippines.
